Graduation rate will be 94% or above. The 10th and 11th grade students will be monitored as well, to be on track for graduation. It will be evaluated mid-term, at the end of each quarter, at the end of the school year, and again at the end of September of the following year.

Advocates tracked students with failing grades each term. Advocates helped recover an average of 18 credits per term. We achieved our goal of over 94% graduation rate with just over 95%.

Action Plan Steps

Three advocates will be employed to work in direct instruction with students to have an impact on their learning.

Advocates will track academics, credits, attendance, and other factors of struggling students. They will coordinate their efforts with teachers and work with the students on their assignments and tests to ensure their success.

Advocates will meet with administrators and counselors each week to track students and review the work they've completed with the students.

Each week advocates identified students deficient in credits and failing classes. They met with an administrator and counselor to develop a plan to help the students recover deficient credits and improve failing grades.

Our teachers in Math, English, and Science worked to help achieve our goal of 80% proficiency on essential standards, which included the process of identifying and refining their essential standards. As you can see from our results we met our goal with half of our teams in the subject areas identified. We will continue to work to achieve our goal on the remaining subjects.

Action Plan Steps

We will Hire a full time Language Arts teacher and a 1/2 time Math teacher to reduce class sizes.

A Math aide will be provided to rotate between math classes throughout the day providing extra support for struggling students.

Teachers will be given professional development opportunities, that will focus on Identifying Essential Standards, Tier 1 Instruction, Assessment, Data Analysis, Interventions and Extensions and working in a PLC. Registration fees and substitutes will be covered by the school.

Summer collaboration grants for teachers to work Essential Standards.

We were able to hire aides in math and English. We also hired a math teacher to give extra support in math and reduce class sizes.

We were also able to take teachers from each identified subject area to conferences to help work through the process of identifying essentials.
